Awards for EFICEEC Staff

The "Jubilee Fund of the City of Vienna for the University of Natural Resources and Life Sciences" was established on the occasion of the 140th anniversary of the University of Natural Resources and Life Sciences, Vienna (BOKU) in 2012.

The aim of the fund is: (i) to enhance science -based cooperation of the city of Vienna and the BOKU, (ii) to strengthen cooperation between science and industry in the BOKU fields of competence; (iii) to encourage the combination of economy with sustainable development, and thus at the same time strengthening the economy and quality of life in Vienna; and (iv) to promote young scientists of the BOKU.

New project - REABLE

Indicator REsearch for SustainABLE Development (REABLE) – new project won

Project content: The issue of participation in sustainability indicator processes has been pointed out as crucial aspect as norm creation and knowledge production is done. The non-involvement of citizens and layman limits the value of the sustainability indicators as local knowledge and practices cannot be accounted for. Knowledge gets lost.

We assume that the opening up of such processes to citizens and lay persons does not only increase legitimacy and accuracy of indicators, but also enhances public awareness for the sustainability topic.

The topic and main focus of his internship will actually be on the "Genesis of the EUTR". Through the internship at EFICEEC Mr. Vejnovic hope to gain more knowledge in these fields and to experience how is it to work for one of the Regional Offices of EFI.

Mr. Vejnovic is active member of International Forestry Student's Association (IFSA), this year as Liaison Officer for EFI.





The proposed research project aims at improving the sustainability indicator selection, definition and evaluation through the involvement of lay persons and concerned citizen by the application multi-criteria analysis. This is done in an experimental setting simulating a sustainability indicator process during two research seminars designed for students at BOKU.

The project will be financed by "Jubilee Fund of the City of Vienna for the University of Natural Resources and Life Sciences" and will last from March 2014 to November 2015.

FACESMAP: European Level Stakeholder Workshop, Rovaniemi 2013

Within COST Action FP1201 (FACESMAP), a stakeholder workshop on "Forest Land Ownership Changes in Europe: Policy and Practice Issues" was organized on 11 December 2013 in Rovaniemi, Finland, as a side event of the European Forest Week (Metsä2013).

Participants from European forest-related organizations discussed trends of changing forest ownership and what is their understanding of the phenomenon of "new forest owners".

The main trend that was indicated in the workshop was that forest owners increasingly do not manage their forests for income any more. They start to see their forests as a hobby, keep them only as a capital, and have no knowledge about or no time for forest management.

It was also said that tradition is important and forest owners still feel a relation and commitment to their forests but that does not necessarily imply that they have an interest in managing them in the traditional forester's sense and for wood production. The growing age of forest owners was also mentioned: both traditional and new forest owners are often over 50 when they get (most often inherit, more rarely buy) a forest. Differences between Western and Eastern European countries was also mentioned (restitution in Eastern Europe).

Cooperation agreement on data collection signed between COST Action FACESMAP and UNECE-FAO Forestry and Timber Section

The preparation of a study on forest ownership in Europe was endorsed as one of the activities of the UNECE-FAO Integrated Programme of Work 2014-2017 at the joint meeting of ECE Committee on Forests and the Forest Industry and FAO European Forestry Commission (Metsä2013) in Rovaniemi, Finland, 9 - 13 December 2013.

The COST Action FP1201: Forest Land Ownership Changes in Europe: Significance for Management and Policy" (COST Action FACESMAP) is a project to be implemented from 2013 to 2016 through establishment of a voluntary research network, and focuses on forest ownership in Europe. The work programme of the COST Action FACESMAP includes the production of a database and a map of forest ownership in Europe.

With the aim of saving resources, avoiding overlap and to encourage the active participation of and cooperation - among member States, the research community and other stakeholders - the UNECE-FAO Forestry and Timber Section (FTS) and the COST Action FACESMAP will work together on data collection of forest ownership in the UNECE region.

The collection will cover quantitative and qualitative data related to forest ownership in countries of the UNECE region, similar to the previous "Private Forest Ownership in Europe" study by UNECE-FAO. EFI, CEPF and other European interest groups also joined the cooperation. Data collection will start in 2014.

4th StarTree General Assembly - Neuberg (Styria, Austria)

The fourth StarTree General Assembly will take place in Neuberg (Styria, Austria), from 02 - 04 April 2014. StarTree is an FP7 project studying the production and marketing of non-wood forest products in Europe.

The meeting will include working groups for each of the StarTree work packages, a session on Regional Case Studies data collection, and work on the state of the sector report. Further sessions will include dissemination activities, administration and financial issues and upcoming plans and deadlines.

A field trip and Knowledge Exchange Event with stakeholders from the Styria RSG is planned for 03 April, with visits to Christmas tree plantation and event called Nature Park "Grassland Cooking". Furthermore, a marketplace will be organised in which many of stakeholders and NWFP companies from Styria will take part.
