### EFI 2014 Annual Conference in Bilbao

The EFI Annual Conference (AC) 2014 in Bilbao, Spain approved the Austrian application to host the **AC 2016 in Vienna**. It will be jointly organized by BOKU and BfW (Austrian Research Centre for Forests).

The 21st Annual Conference was held in **Bilbao**, the European Forest City 2014, and the recent developments within EFI were discussed in a new interactive modus. In addition, a seminar on the future of bioeconomy in Europe was held in a panel set-up.

The aim is to connect young European forest scientists with their peers and senior scientists. Young researchers were invited to present their recent work. The winning candidates had been selected according to innovation. scientific policy relevance and interdisciplinary nature of their work. From the EFICEECnetwork, Zuzana Dobsinska from the Technical University in Zvolen was selected and granted financial support. The topic of her presentation was "Coordination by hierarchy and networks in policies relevant for the forestry sector: actors, relations, processes addressing crosssectoral relations in forest policy".

### **COST Action FACESMAP meeting in Freiburg**

The 4<sup>th</sup> Working Group (WG) meeting with Travellab of COST Action FP1201 (FACESMAP) took place in Freiburg, Germany from 15-17 September 2014, hosted by the University of Freiburg, Faculty of Environment and Natural Resources.

Around 60 participants from 29 countries gathered to work on the topic of forest land ownership changes. We were happy to welcome also partners of EFICEEC-EFISEE among other participants.

The meeting was mainly dedicated to the work of the sub-groups. At the meeting, interaction with local stakeholders was organized using a "Travellab" approach. This comprised focused discussions with local stakeholders in the field and workshops with stakeholders in afternoon sessions. Visit to the Black Forest (Schwarzwald) was organised on the first day of the meeting.

#### Summary of C&I development in Europe

Criteria and Indicators (C&I) for Sustainable Forest Management are attracting increasing attention these days. There are several processes ongoing: (i) a working group on indicators by the European Commission following the new Forest Strategy, (ii) further work on the Pan-European indicators in the context of Forest Europe, and (iii) a global project on SFM indicators run by FAO.

# **COST Targeted Network CAPABAL kicked off**

The kick-off of the new **COST Action CAPABAL TN1401** took place in Zagreb on 2<sup>nd</sup> October 2014. CAPABAL (**Capacity Building in Forest Policy and Governance in Western Balkan Region**) is a targeted network aiming at capacity building in forest policy and governance in the Western Balkan region. The Croatian Forest Research Institute will act as a grant holder and Dr. Dijana Vuletić, Director of the Institute, is appointed as a Chair of the Action. Bernhard Wolfslehner (EFICEEC Head of office) and Silvija Krajter Ostoić (EFISEE office Coordinator) are appointed as dissemination task force.

So far 12 countries accepted the Memorandum of Understanding (Austria, Bosnia and Herzegovina,
