EFICEEC has a new internship. Ms Laura Bourdon, a French master student from ISARA-Lyon (Graduate School of Agriculture, Environmental Studies and Food Sciences), joined the EFICEEC team in JUN 2011. She will be with the team until SEP 2011. Her main task is to research agroforestry and the environmental and economical provisions it produces for the society. The main question of her research is how sustainable agroforestry can be made to support biological diversity. At the end of her internship period, she will write a scientific article on the topic.



# EFICEEC at Science for Carpathians (S4C) meeting in Bratislava, May 26-27, 2011

Bernhard Wolfslehner was invited to the Scientific Steering Committee Meeting of S4C in the wake of COP3 of the Carpathian Convention. S4C is a scientific network that is to implement the Research Agenda for the Carpathians, e.g. by means of the annual Forum Carpaticum. In the meeting, synergies between S4C and EFICEEC were identified and it was discussed how to link the networks and its communications means. Formal modalities of cooperation will be decided in the coming months.

## **Co-operations with FAO on track**

Seeking synergies with relevant initiatives and networks, future co-operations with FAO have been set on fertile ground in 2011. After establishing a stable mode of communication with FAO Regional Office in Budapest, a study on Forest Owner Associations and Cooperatives in selected CEE countries has been launched by FAO HQ and will be conducted by EFICEEC and its partners. The study shall be finalised by OCT 2011, and shall give insights into potentials and barriers of FOAs and FOCs in CEE. Further collaboration with FAO and CEPF on this topic is highly envisaged.

and regional level to tackle climate change effects on practical level.

# UNECE/FAO meeting in Geneva JUL 4-5, 2011

EFICEEC was present at the high level UN-ECE/FAO meeting, organized by UNECE, in Geneva July 3-5. During the two day workshop, a group of experts assembled to discuss issues linked to payments for different ecosystem services (PES). The workshop intended to help governments and stakeholders share experiences and understand which policies and incentives have been and could be most effective in implementing PES schemes. With a focus on forest and water related ecosystem services, the workshop participants discussed how the contribution to PES schemes can facilitate the transition towards a green economy.

The outcome of this workshop will feed into an Action Plan on Forests and the Green Economy which will be discussed at the joint session of the UNECE Timber Committee and FAO European Forestry Commission on OCT 10-14, 2011 in Antalya, Turkey and presented as a sectoral contribution at the Rio+20 summit in 2012.
