# **POLYFORES kicked off and taking shape**

Dr Helga Pülzl and Marcel Mallow, from the EFICEEC team, attended the POLYFORES (Decision Making Support for Forest Ecosystem Services in Europe – Value Assessment, Synergy Effects and Trade-offs) project kick-off meeting in Uppsala. The Swedish University of Agricultural Sciences (SLU) hosted the meeting. The project will be carried out during the next 3 years and EFICEEC-SEE/BOKU team will contribute to comprehending societal perceptions of and political strategies towards Forest Ecosystem Services (FES).

The meeting in Uppsala, with project members from Sweden, Austria, Germany, Spain, Russia and Norway, yielded important results in coordinating definitions of key terms as well as in refining

conceptual and methodological approaches. A key pillar of Marcel's and Helga's work in this project is a societal value assessment of FES in the form of a multi-country online survey. The survey methodology to follow was discussed in-depth in the respective working group. Further discussions were held on how these perceptions and values of FES translate into policy and how this will be analysed at working group level. Thanks to the stimulus from the kick-off meeting, both value assessment and policy analysis activities are now entering into advanced stages and their implementation with the project partners will start early next year.
