Around 120 participants made the 2016 EFI Annual Conference in Vienna a highly appreciated one. Over two days the EFI member organisations discussed how to better connect science and knowledge to action. The new EFI strategy was introduced - it will reflect the strong connotations of EFI's work to policy support, while mobilising the expertise of its network and support access to new forms of collaboration. This year's Scientific Seminar built on one of the very core domains of EFICEEC: the role of innovation in an upcoming bioeconomy development. We made a journey from theoretical foundations of innovation research, to the EU dimension of research and innovation, and could explore a variety of practical examples how innovation could manifest in reality, be it new forms of hardwood use, the increasing significance of wood constructions, or how to further develop forest genetic resources.

A field trip to the Vienna water protection forest in perfect weather conditions made the whole event a

round thing. Many thanks to all supporting hands, and to so many of you for showing up.

The last General Assembly meeting in Wales included a public **Wild Forest Products Fair** with workshops, demonstrations and exhibitors from Wales and European project partners. EFICEEC/BOKU organised a workshop discussion on successful entrepreneurship in the field of wild forest products which resulted in three important elements: passion, patience and practice.

## **COST CAPABAL Final Meeting**

The Final Meeting of the first phase of **COST Action CAPABAL TN1401** was held from **23–25 August 2016 in Sarajevo, Bosnia and Herzegovina.** The event was organized by the Faculty of Forestry University of Sarajevo.

The aim of the meeting was to present and discuss the outcomes of the activities of three Working Groups, STSMs and Training Schools. Key note speakers were Faruk Mekić who discussed imperative of regional research cooperation in the Western Balkans, Martin Šolar who presented vision lauched on the project website. The Innovation Generator includes short descriptions of innovation tools and guidelines, an innovation case database and inspirational questions and stories.

Besides of scientific articles and policy briefs, a book on "Wild Forest Products" is under preparation under the EFI "What science can tell us" series. Most project outputs are now in the finalisation stage and will appear soon on the project website.

STSM participants demonstrated how their activities could fit to a coherent forest policy research in SEE. The international scientific and expert conference "Natural resources, green technology and sustainable development/2" – GREEN 2016 was held Oct. 5–7, 2016 in Zagreb. It was jointly organized by the Croatian Forest Research Institute and the Faculty of Food Technology and the Biotechnology, University of Zagreb and supported by the Faculty of Forestry, University of Zagreb, the Institute for Adriatic crops and karst reclamation and the Croatian Society of Biotechnology.

Main topics included: productivity & sustainable management of ecosystems, food as natural source of functional ingredients, green technology for sustainable production, biomass for bio-based economy, environment and ecosystem services.

# The First NNEXT training school organised in Croatia – "Non-native tree species in Europe in the viewpoint of climate change: challenges, risks, opportunities – trade-offs"

The 1st NNEXT training school took place in Zagreb and educational and training facilities in Zalesina (Faculty of Forestry, Zagreb), from 23–27 August 2016. It was organised by Croatian Forest Research Institute, in the frame of COST Action FP 1403 NNEXT. The main objective of this training school was to shape the opinion and initiate brainstorming on (I) the opportunities of growing non-native tree species (NNTS) in Europe and (II) the newly emerged conflicts in NNTS management. It also aimed at exchange of experience and information among young researchers, thus creating a network for future collaboration.

The school included fourteen participants from twelve EU countries and six trainers from four EU countries. Ecology and productivity of NNTS and their provenances in relation to native tree species were presented on the examples (natural forest stands as well as trial plots) in four different bio-climatic regions of the Republic of Croatia. These trial plots are the object of long term monitoring, which lasts for fifty years. Field excursions were conducted on the area of five Forest Administration Offices (Zagreb, Koprivnica, Karlovac, Delnice, Buzet). Opportunities of growing NNTS were addressed during the school, such as:

- filling the gaps in the forest after calamities;
- enhancement of production and quality/diversity of products
- expansion on or creation of new local markets
- enhancement of options for bioenergy production
- better capacity utilization; creating better options for stability on landscape level
- lowering connectivity of pests/diseases/burning material
- help in sustainability of forest stands, soils, and ecosystem services, etc.

Besides the plenty of opportunities, there are challenges and risks that will be met in the future, and which have been addressed during the workshop. In addition, participants still work in groups on wrapping up and preparing conclusions and the discussions on NNTS opportunities and current and future issues. The aim is to map their degree of implementation in the country and create indices that will be used for supporting sustainable growth in Greece for the years to come. In this direction, it has set a number of goals including the assessment of the current status of Greece in achieving the SDG's, the provision of direction for national and local policy making, the development of and start-ups in environmental businesses management, health benefits, adoption of technology and lowering the cost of implementing EU Directives. Several tasks have been planned, including the development of the first Greek electronic library that will gather all information (research results, models, methods, end-user products) relevant for mapping the degree of implementation of the SDGs in Greece. In November 2016, UN SDSN-Greece will be hosting this year's annual conference of the Mediterranean UN SDSN.
