EFI 2017 Annual Conference

At the EFI Annual Conference 2017 in Oslo, the new EFI strategy was presented. He explained how the integrated system of programmes (Bioeconomy, Resilience and Governance), research networks and facilities will benefit the whole EFI network. IUFRO 125th Anniversary Congress "Interconnecting Forests, Science and People"

The IUFRO's five-day congress marked the organization's 125th anniversary and took place from 18th to 22nd September in Freiburg, Germany. A bundle of "Science in Dialogue" events (e.g. Science meets Policy or Science meets Business) with interactions and presentations by international high level stakeholders took place at the event as well as a total of 1 879 scientific presentations. These contributions were submitted by scientists from 89 countries, many of them from our EFICEEC-EFISEE network. The EFICEEC team was nearly fully present at the congress. For instance: Stefanie Linser organised the session "The potential contribution of forest related indicators to global issues"; Helga Pülzl chaired the session "Europe Inside/Outside-The export of European forest policies. objectives and architecture through public and private governance arrangements"; Bernhard Wolfslehner, Gerhard Weiss, Patrick Huber, Helga Pülzl, Stefanie Linser and Alice Ludvig from the EFICEEC team presented several papers at the congress. The **EFISEE team** co-authored two papers, which were presented by Mirjana Stevanov at the congress. The first paper "*Publishing survey-based research in forestry journals*" was presented during a session "*Publishing forest and wood science: challenges for editors and publishers*". The second paper "*Implementation of forest-related policies by state forest institutions from former Yugoslavian countries: state of the art and future perspectives*" was presented during a session "*Forest policies in the Baltic and Central and Eastern European (CEE) regions*".

EFI What Science Can Tell Us-study on "Natura 2000 and forests" was presented in a ThinkForest event in Brussels

The study "*Natura 2000 and forests: Assessing the state of implementation and effectiveness*" was published on 21st September. It was commissioned by EFI under the frame of its Multi-Donor Trust Funds and carried out under the lead of Metodi Sotirov (University of Freiburg, DE) and Gerhard Weiss (BOKU, EFICEEC, AT) with contributions from a European-wide authors team, including Zuzana Sarvasova (NLC, SK).

The study was based on comprehensive literature reviews on the implementation of Natura 2000, its ecological effectiveness and economic efficiency and on related studies such as the Biodiversa-ERAnet project BeFoFu or the Natura 2000-sub-group of the COST Action FACESMAP.

SIMRA-Research Report "Political Framework Conditions Policies and Instruments for SIs in Rural Areas" now publicly available

Within the SIMRA project (Social Innovation in Marginalized Rural Areas), the first research report (Deliverable 6.1.) under lead of the EFICEEC team (Alice Ludvig, Gerhard Weiss, Ivana Zivojinovic) has been published by the European Commission and is accessible through the SIMRA website (http://www.simra-h2020.eu/index.php/deliverables/). The analysis on Political Framework Conditions Policies and Instruments for Social Innovation (SI) in Rural Areas takes into account broader governance framework conditions in order to understand how they support social innovation (SI) in rural areas. The report examines SI policies as both sectoral and cross-cutting innovation policies. The methods applied are in-depth desk research (secondary literature and primary documents), qualitative in-depth expert interviews with national and international policy experts and researchers, focus groups with stakeholders and SI case study report screening for assessing the policy instruments of relevance for SI. It identifies and distinguishes three key dimensions of policies: (i) the ones that address vulnerable social groups (e.g. Social Policies), (ii) the ones that enable in a broader way the integration of social, economic and environmental dimensions (e.g. Cohesion policies), and (iii) policies that enable reconfigurations of civil society participation and institutional change in rural areas (e.g. the CLLD/Leader method or the European Innovation Partnerships).

Erasmus+ Project CIA2SFM stepped into its final year

The second year of the CIA2SFM project was fruitful in the terms of the outputs. Project partners from Austria, Croatia and Slovenia collaboratively developed a new educational programme in four languages. The educational programme named *"Sustainable forest management: From theory to practice"* is a multilingual and multimedia e-learning module, which will be soon available to the future e-learners on the Moodle platform.

Furthermore, partners continuously carried out promotional activities. Accordingly, the project's results were recently promoted at **the Days of Mobility and Education in Zagreb** from 6 - 7 October, 2017 and at the **55th AGRA fair 2017** in Gornja Radgona in Slovenia (26 - 31 August, 2017). Moreover, by the end of the year project has scheduled two events. The 2nd short-term joint staff training will be held from 23-27 October in Zagreb in organization of the Institute for Development and International Relations, while the 5th transnational meeting of the project will be held in organization of the BFW in Vienna on the 15th of November.
