EFI 2015 Annual Conference

The 2015 Annual Conference and the Seminar "Forest policy research from theory to practice", was held in Saint-Petersburg, Russia, on 30 September – 2 October 2015. The co-organiser for the Conference was Saint Petersburg State Forest Technical University.

The scope of this year's Seminar was to present the state of forest policy research and practice in sciencepolicy interface in Europe and Russia, and to discuss the needs and possible contribution of science into policy-making. The seminar was dedicated to the memory of Prof, Peter Glück, who passed away in March 2014, and was an instrumental person in both developing EFI and establishing new standards in forest policy research. Helga Pülzl and Bernhard Wolfslehner contributed actively to the seminar amongst a who-is-who of the forest policy research community.

The Conference gathered good participation – in total of over 110 participants from 23 countries in Europe

and beyond participated in the events during the conference week.

ARANGE Science Conference "Mountain Forest Management in a Changing World"

With the aim to discuss the potentials and limitations of current and potential future management of mountain forest ecosystems providing a portfolio of ecosystem services under risk and uncertainty the ARANGE project organized an open science conference "Mountain Forest Management in a Changing World" in the High Tatra Mountains, Slovakia (7-9 July 2015). 130 registered participants, including scientists, practitioners, international mountain forestry stakeholders and policy makers participated and contributed with 48 oral and 31 poster presentations in dedicated scientific sessions.

A field trip to the Slovakian Case Study Region (Kozie Chrbty) pinpointed regional issues and fostered the knowledge transfer between science and practice. Bernhard Wolfslehner moderated the final day of the Conference, including a panel discussion and a stakeholder workshop, both targeting at bridging the gap between science, policy and practice and elaborating on a possible European Mountain Forest Research Agenda.

CAPABAL TN 1401 MC & WG Meeting in Vienna, Austria

The second MC and WG Meeting with Conference, Third Core Group and Dissemination Meeting of the CAPABAL Action was held in Vienna from 16-18 September 2015. The event was hosted by the University of Natural Resources and Life Sciences (BOKU) Vienna in Austria.

The aim of the meeting was to present and discuss the preliminary outcomes of the activities of three Working Groups, STSMs and Training Schools and to plan future activities. Key note speakers were Prof. Dr. Karl Hogl (BOKU) who presented the evaluation of the Austrian Forest Dialogue, Prof. Dr. Gerard Buttoud who talked about designing national forest programmes in the context of global change and a need for systemic forestry, and Prof. Dr. Margaret Shannon who discussed socio-economic resilience as a communicative action. The next WG and MC meeting has been scheduled for March 2016 in Podgorica, Montenegro, and the next training school has been announced for February 2016 in Padova with the topic of writing project proposals.

EFICEEC - EFISEE @ Durban FAO World Forestry Congress

The XIV FAO World Forestry Congress in Durban, the first to be held in Africa, brought together almost 4,000 delegates form 142 countries in order to discuss key issues of the sector and potential ways to address them. The central theme "Forests and people: Investing in a Sustainable Future" aimed to pinpoint the crucial role of World's forests in income generation, employment creation and equity and the vital links between forests and climate change, biodiversity conservation and sustainable water resources. Within an array of plenary sessions, subtheme dialogues and special (side) events the largest gathering on forests this year set out to elaborate on a vision for the future of forests - resources that hold the potential to play a decisive role in combating hunger, poverty as well as climate change.

Besides the **Durban Declaration**, that outlines a series of actions needed to realize the vision, the Congress stressed the essential role of forests to achieve the Sustainable Development Goals in a **message to the United Nations Sustainable Development Summit**, recommended a **set of actions** to the Conference of Parties (COP) to the United Framework Convention on Climate Change and launched an international five-year **forest and water action plan**.

Special attention was drawn to the youth, as vital stakeholders in sustainable development, providing room to bring in their perspectives to the Congress in a special event on **forests for the future**.

ERASMUS+ project "Cooperation for innovative approach in sustainable forest management training"

EFICEEC and EFISEE offices further strengthen their collaboration with work on new ERASMUS+ project. The three year project "Cooperation for innovative approach in sustainable forest management training" (CIA2SFM) is result of strategic partnership of seven organisations from Croatia, Austria and Slovenia aiming at developing of new curriculum for Lifelong Learning (LLL) on the topic of sustainable forest management. The innovativeness of the approach is in providing an e-learning platform that will be developed jointly and be flexible enough to be implemented transnationally. Croatian Forest

Research Institute with its EFISEE office is coordinating the project gathering six other organisations- BOKU, Austrian Federal Research and Training Centre for Forests, Natural Hazards and Landscape (BFW), Institute for Development and International Relations (IRMO) from Croatia, Slovenian Forest Institute, Slovenian Forest Service and Slovenian Institute for Adult Education.

The kick- off meeting date is set to 23 October 2015 in Zagreb. Webpage and Facebook page are so far under construction.

Regional Journal presentation: BALTIC FORESTRY


BALTIC FORESTRY (ISSN 1392-1355) is a peer reviewed international scientific journal which publishes original articles as well as short reports and review papers on forest science and forestry throughout the Baltic Sea region and elsewhere. The Baltic Sea region is rather unique through its intrinsic temperate and boreal forest environment and distinguished geographical and social conditions. The forest science there has been affected by the ideas from both the East and West.

journal BALTIC 2015, the FORESTRY In celebrates its 20 year anniversary. The journal is published since 1995 when forest research institutes and universities from Baltic Countries - Estonia, Latvia and Lithuania - joined their efforts in publishing their research results. The founders of the journal are: Institute of Forestry of Lithuanian Research Centre for Agriculture and Forestry, Aleksandras Stulginskis University (Lithuania), Institute of Forestry and Rural Engineering of Estonian University of Life Sciences, Latvian State Forest Research Institute "Silava" and Latvian University of Agriculture. Members of Editorial Advisory Board are well-known scientists from Baltic Countries and Sweden. They act as subject editors and as reviewers of the papers. International scientists from over 35 countries are involved in the review process of submitted manuscripts.

Scientists from 30 countries have submitted their manuscripts for publication in BALTIC FORESTRY so far.

The Journal is published two times a year: No.1 (December). Journal (April), No.2 The is abstracted/indexed in: Thomson Reuters Web of Science Citation Index Expanded, **SCOPUS®** Database, Forest Science Database, Zoological Record, CAB Abstracts, Agroforestry Abstracts, Forestry Abstracts and other international databases. The 2014-year impact factor is 0.41.
