Outstanding national Set of Indicators for SFM

Stefanie Linser from EFICEEC was coordinating the Revision of the Austrian Indicators for Sustainable Forest Management. The set contains the pan-European indicators for SFM as well as 33 indicators of additional national importance. The indicators are related to goals of the Austrian Forest Program and the Austrian Forest Strategy 2020+ and contain agreed targets and thresholds as well as assessments of the achievements which makes this set unique in comparison what is so far available in other A selection of key indicators is countries. presented in a separate leaflet. The Report on the Austrian Set of Indicators for Sustainable Forest Management was adopted by the Austrian Forest Forum at 16 May 2017.

KICK-OFF Meeting CAREFORPARIS in Vienna

The Kick-off meeting of the Austrian project CAREFORPARIS ("Adaptation for carbon efficient forests and the entire wood value chain (including a policy decision support tool) - Evaluating pathways supporting the Paris Agreement"), funded by the Austrian Climate and Energy Fund (ACRP), took place April 24 in Vienna. It is a two-years project that is led by the Environment Agency Austria (Umweltbundesamt).

For EFICEEC, Alice Ludvig and Gerhard Weiss are leading the socio-economic part and will develop proposals for modifying the political and legal framework conditions in Austria for forest management and wood product use towards a GHG-optimised use. The project estimates with six scenarios the impacts of climate change and silvicultural adaptation measures on the significant GHG balance of the Austrian forests and related wood products/fuels (incl. avoided emissions from substitute products/fuels) until 2150. In addition, an analysis of these impacts on the Austrian forest and wood industry sector (the biggest economic sector in Austria) will be carried out (e.g. quantity and quality of wood delivery, needed technical adaptations). The results of the project offer basis for needed societal transformations and adaptations to reach the Paris Agreement targets of a balance between GHG emissions and removals post 2050 and will identify needed adaptation measures in the Austrian wood industry due to silvicultural climate change impacts and consequences in the Austrian forests.

The first meeting of the second stage of the COST TN CAPABAL in Skopje

At the beginning of the April was held the first meeting of the second stage of the COST Targeted Network (TN) CAPABAL. The event was hosted by the Faculty of Forestry in Skopje. During the threeday event the Core group, Management committee, Working groups and Dissemination meetings were attended by a total of 40 researchers, policy decision makers and practitioners.

The goal of the meeting was to determine and to present the future steps of the Action and working groups. The Strategic Regional Research Agenda, which main topics and research lines were adopted by the Management committee, was further developed and discussed with all the participants of the meeting. Next meeting of the CAPABAL Action is planned for November, 2017 in Poland (Krakow).

Solutions for Wood Mobilisation in Europe (SIMWOOD project final conference)

Regional, national and European stakeholders interested in wood mobilisation are invited to the conference 'Solutions for Wood Mobilisation in Europe'. The programme is designed to address both forest practitioners (forest managers, entrepreneurs, wood suppliers etc.) and policymakers.

From October 12 to 13, 2017, the members of the EU research project SIMWOOD will present their findings of four years of region-based research action and trans-European cooperation at a final conference in Paris. The SIMWOOD project aims to increase the mobilisation of wood from forests and woodlands in Europe. The project reaches out to stakeholders and regional initiatives with the aim of engaging and mobilising forest owners and practitioners, promoting collaborative forest

management and ensuring sustainable forest functions.
